ACTIVE GROW LLC 5-YEAR LIMITED WARRANTY FOR SG300 LED HORTICULTURAL LUMINAIRE

Active Grow warrants to its customer and the original end user the LED electronics and components of its properly installed LED products, to be free of defects in material and workmanship, in normal use, for a period of five (5) years from the date of shipment by Active Grow. The painted finish is not covered by this warranty.

Active Grow, at its sole option, will repair, replace, credit or refund, any warranted product returned to it that it determines to be defective. Customer or consumer must return the product, transportation prepaid, to Active Grow at 12345 Lake City NE, Seattle, WA 98125 within the warranty period. No return of products will be accepted without a Return Goods Authorization ("RGA"), which may be obtained by calling 206-792-9799. This warranty excludes and there is disclaimed liability for labor for removal of this product or reinstallation of this product or a replacement product. In addition to complete failure, defects include lumen depreciation to levels below 70% of initial lumen output within warranty period.

This warranty is void if the product is installed in violation of the National Electrical Code, or any applicable local electrical codes, or in an improper environment, misused, opened, abused, or altered in any manner, or is not used under normal operating conditions, or not in accordance with any labels or instructions. This warranty does not cover damages due to environmental conditions, acts of nature, animal or insect activity, or power surges.
